### **ACTION TECHNOLOGIES & SWISS RE WIN WORKFLOW MEDAL**

#### **– Oakland-based BPM company takes home sixth award from WfMC –**

October 24, 2005 – Oakland, Calif. - Action Technologies ([www.actiontech.com](http://www.actiontech.com)), a 20-year-old software firm specializing in business process management, today announced that the Underwriting Cockpit developed by Swiss Re ([www.swissre.com](http://www.swissre.com)), one of the world's most prestigious financial-services firms, has been awarded a silver 2005 Global Excellence Award by the Workflow Management Coalition (WfMC) and the Workflow And Reengineering International Association (WARIA). These annual medals are presented to organizations that demonstrate innovation and excellence in Business Process Management (BPM) and workflow implementations, and since 1999 no company has won more of these awards than Action Technologies.

Previous Action Technologies' customers that have also won excellence awards include Credit Suisse Financial Services, International Truck & Engine Corporation, R.R. Donnelley, WorldCom, and Lubrizol. Action Technologies' ActionWorks<sup>®</sup> suite is the only BPM software that models the "natural" ways that knowledge workers interact, rather than the task-based methodology found in standard workflow solutions. Because ActionWorks is based on a system of negotiations and commitments, accountability rests with the individual performers who have agreed to complete a request. The company has won more than a dozen major industry awards and was positioned in the visionary quadrant in the last two Gartner Pure-Play BPM Magic Quadrants.

In 2004 Swiss Re's Financial Services Business Group determined that the best way to improve its performance was to implement a workflow system to create best practices that would empower underwriters to assess the highest-performing deals faster and to expedite managerial approval. To make this next step in performance improvement,

the Business Group developed the Underwriting Cockpit, including the ActionWorks Suite by Action Technologies, to formalize reinsurance risk underwriting processes. The cockpit has reduced deal-processing times by a third and has enabled the Financial Services Business Group to mitigate its own risks by increasing process quality and speeding the throughput of deal approvals.
